

PRIVACY POLICY

Information on the use of personal details according to Organic Act 15/1999 for the protection of personal details. This is the privacy policy implemented by (hereinafter "Privacy Policy") **DE RUY PERFUMES S.A.U.** (hereinafter "**De Ruy Perfumes**") with corporate address at Carretera de la Esclusa, ZAL, 2.1., 41011 Seville (Spain).

The objective of our Privacy Policy is to explain the privacy practices implemented by "**De Ruy Perfumes**" and to let you know the kind of personal data that we collect from our users, the way we collect such data, how we make use of it and the circumstances under which we reveal it to third parties, how to access, update or delete your personal data and the devices implemented to protect them. To all effects the term "User" in the Privacy Policy refers to you.
